DIXIE STATE COLLEGE COURSE OBJECTIVES:

All mathematics courses at Dixie State College will:

1. Require students to perform mathematical processes, including fractions, percentages, decimals, proportions/ratios, algebraic equations, and/or calculus techniques.
2. Provide students with application problems that use a variety of methods, including arithmetic, algebraic, and geometric.
3. Challenge students to make inferences from mathematical models that include formulas, graphs, and/or tables.
4. Provide students with real-life applications that use a variety of mathematical functions.

Upon successful completion of Math 1050, a student will demonstrate through testing the ability to:

1. Apply function notation.
2. Determine symmetries that exist in the graph of an equation.
3. Graph polynomial functions and find their intercepts and extrema.
4. Analyze the key components of the graphs of polynomial and rational functions.
5. Compute the composition and inverses of functions.
6. Graph exponential and logarithmic functions.
7. Apply properties of exponents and logarithms in expressions and equations.
8. Solve systems of linear equations, including using determinants.
9. Solve nonlinear systems of equations and inequalities.
10. Find terms and sums of arithmetic and geometric sequences and series.
11. Compute the terms of a binomial expansion.

INSTRUCTOR EXPECTATIONS:

1. Attendance is of prime importance in any college class but especially in a mathematics class. Therefore, students should make every effort to show up.
2. Homework (including the chapter test) will be collected, graded, and returned on each test day. Late homework will receive half-credit; too-late homework will receive no credit.
3. A graphing calculator is required.
